GENERAL INFORMATION SECURITY POLICY



The company "HELLENIC TRAIN - RAILWAY COMPANY SOCIETE ANONYME", with the distinctive title "HELLENIC TRAIN S.A.", is the main provider of rail passenger and freight transport in Greece. The Company provides its railway services using the network and the railway infrastructure owned by OSE and under the Regulatory Authority for Railways (RAS). The Company is a member of the International Union of Railways (UIC), the Community of European Railway and Infrastructure Companies (CER), the International Rail Transport Committee (CIT) and Forum Train Europe (FTE), actively participating in the international exchange of know-how and good practices. Furthermore, as the main provider of railway transport services in Greece, HELLENIC TRAIN S.A. is designated as an "essential entity" under Law 5160/2024, which incorporates the EU's NIS2 Directive.

The main objectives of the company include:

- The development, organization and operation of urban, suburban, regional, intercity and international passenger and freight rail transport, as well as all forms of transport via fixedtrack systems.
- The development and operation of combined transport.
- The development and operation of bus transport, both domestically and abroad.
- The provision of supply chain management (logistics) services and related activities.
- The organization and provision of passengers' bed rest and catering services.
- The provision of consulting services and studies related to the company's activities.

HELLENIC TRAIN S.A., recognizing the importance of information protection and information systems security, has developed and implements an Information Security Management System (ISMS) in accordance with the requirements of the International Standard ISO 27001:2022, enhancing compliance with the legal and regulatory obligations of Law 5160/2024 and adhering to the highest standards of cybersecurity and resilience, to ensure the continuity of its critical services.
